The meeting was called to order by President T. Wipperfurth on July 11, 2023 at 4:00 P.M. All public notices have been posted to meet with the open meeting law and the building is accessible for the handicapped.

Approval of Agenda 7-11-23: T. Wipperfurth made a motion to approve 7-11-23 agenda. R. LaPlante seconded the motion. All in favor, motion carried.

Approval of Minutes 6-13-23 Meeting: T. Wipperfurth made a motion to approve the minutes for the 6-13-23 meeting; R. LaPlante seconded the motion. All in favor, motion carried.

Agenda Item #4: Discussion of different customer payment options: J. Benson informed the board that the district is having lots of issues with our third party vendor Point and Pay for over two months. Customers are unable to pull up their account through our website bill payment tab resulting in some not paying through this method or calling to pay their bills over the phone. This results in time lose in the office and inconveniences for all involved. Point and Pay has not resolved the issue, they are losing over half of the district's account file causing these problems. J. Benson presented the board with a handout with the different banking options available to the district that would also offer our customers different options to pay. J. Benson went over each option presented from Peoples State Bank, Incredible Bank, US Bank and HeyGov.com. There was a brief discussion about the different fees involved and what each can provide to offer the best services to the district and our customers. R.
